I am by vocation, an attorney licensed in the State and Federal Courts of both Minnesota and North Dakota, practicing with the law firm of Dolan and Besser; and, by avocation, an environmentalist and angler pursuing both warm water and cold water fishes.

I am currently a citizen member of the Minnesota DNR's Mille Lacs Fisheries Advisory Group and the Esocid (North Pike/Muskellunge) Fish Workgroup.

I have described myself as a "hiologist gone bad" after abandoning science for the law.
