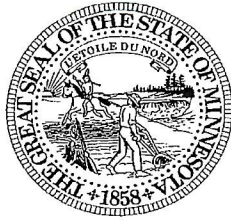

I am a member of the Rochester Public School Board (2011-2018) which oversees a general fund budget of approximately \$211,000,000 and a total budget of approximately \$260,000,000. This past November we passed an operating referendum which is designed to forestall budget reductions through the 2019-2020 school year barring any additional unfunded mandates which are about \$16,000,000 for the 2016-17 school year.

I have served as Vice Chair (2011) and Chair (2012), and am currently Vice Chair. I have written and revised RPS board policies, was a member of the Core Planning Team (2012) which was comprised of 29 citizens and district employees.

During my tenure on the RPS Board we hired an interim Superintendent and Superintendent (2011), launched all day every day kindergarten (\$7 M in building expansions), purchased and repurposed a space for our Alternative Learning Center, created the Career and Technical Education Center (C-TECH), and partnered with community members and businesses. We have recently initiated community groups to discuss equity and disproportionate discipline as a result of the OCR report (which had no findings).

I have completed Phases I, II, III and IV through the Minnesota School Boards Association (MSBA), have attended MSBA work sessions at the January Winter Conference (2011-2016). In addition, I also attended the National School Boards Association annual conferences (2013 - 2016) during which I met fellow school board members from across the country. We shared ideas, successes and failures.

As a professional music educator and elected School Board member, I have the skills and understanding to promote and support opportunities, mentorships and training throughout Minnesota for music teachers and students. The Perpich Center for Arts Education is one vehicle which will help to accomplish this. As our state becomes more diverse, it is extremely important to provide all students with the skills they need to be successful, to prepare them for occupations that do not yet exist, and enable them to pursue their dreams. Nationally and statewide STEM is emphasized; however, the importance of the arts (visual and performing) is of paramount importance, especially for our English language learners, immigrants, and students in poverty.

The arts unleash creativity which is essential for success in any field. The arts nurture and support our common humanity, foster community and teamwork, and allow students to explore themselves as they work with others during the creative process.

My professional background, experience and success in music education and my role as a strong school board member for RPS make me an ideal candidate for the Perpich Center for Arts Education Board.
