
I am writing to apply for reappointment to the position of Emergency Physician on the Minnesota Emergency Medical Services Regulatory Board.

It has been a great honor to serve the citizens of Minnesota in my current role as the State EMS Medical Director and Chair of the Medical Director Standing Advisory Committee of the EMSRB since 2014. In this position I am proud of the accomplishments which I have led including the following:

1. Represented MN on the Medical Directors Council of the National Association of State EMS Officials (NASEMSO). I was elected to the position of Secretary in 2016.
2. Improving the medical care for patients in rural Minnesota while protecting the fiscal sustainability of rural ambulance services.
 - a. Authorization to allow EMT's to utilize D10W to raise the blood sugar of hypoglycemic patients eliminating the need for ambulance services to purchase glucagon which is a very expensive medication.
 - b. Authorization for EMT's to use a volume limited syringe to deliver epinephrine to patients with life threatening allergic reactions eliminating the need to purchase commercial "Epi pens" which cost over \$400.
3. Partnership with the legislator in crafting HF 85 authorizing EMS providers to administer medications carried by a patient to treat a life threatening condition. This was signed into law by in May, 2019.

If I am reappointed I will continue to seek ways to improve the health and safety of Minnesotans through the leadership of the Emergency Medical Services Regulatory Board.
