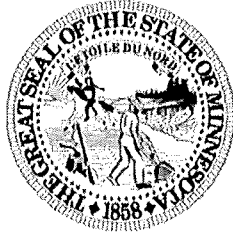

Assisting on all aspects of the moose research project, including radio-tracking, browse collection and surveys, collection of fresh material from harvested moose and roe deer *Capreolus capreolus*, data recording, and captive rearing/feeding of moose calves and roe deer fawns. I have gained extensive

laboratory experience, including analysis of plant nutrient content using Micro-Kjeldahl methods and atomic absorption spectrophotometry, and determined digestibility of forage species using in vitro methodology.

I have censused hazel grouse *Bonasa bonasia*, live-trapped beaver *Castor fiber* for implanting of radio transmitters, assisted in capturing roe deer and moose for radio-collaring, and worked with a Geographical Information System (GIS). My travels to and participation in various professional meetings and conferences have taken me across Europe, the former Soviet Union and Baltic States, as well as North America (for more details see below under Professional Activities). Further, I have traveled to Austria, China, Czechoslovakia, Germany, Israel, Nepal and Thailand on ecology field trips, and also performed various types of fieldwork in Alaska, Finland, Norway and Russia.

I have gained considerable teaching experience by giving numerous lectures, in both English and Swedish, to wildlife and forestry researchers, graduate and undergraduate students, as well as to hunters' and special interest groups. During the summer of 1995 I acted as the primary advisor for Erik Thorson, an undergraduate in the Department of Fisheries and Wildlife at the University of Minnesota. This cooperation led to a scientific paper (see Faber & Thorson

under Publications) which was included in my Ph.D. thesis. Other activities have included making English language improvements on many scientific manuscripts and reports from colleagues across Fennoscandia, China and Russia. Further, from 1996-98 I was an instructor for the Swedish Hunter's Proficiency Test (Jägarexamen) at Grimsö Wildlife Research Station.
