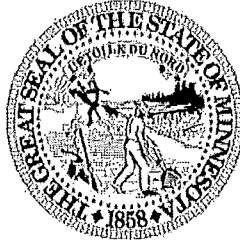

To Whom It May Concern:

I am writing this letter to express my interest in being considered to join the Board of the Perpich Center for Arts Education. At the end of next month, I will retire after serving as chair of the Department of Theatre and Dance at Minnesota State University, Mankato, and as Artistic Director of Highland Summer Theatre, for the past 35 years. I have spent over 44 years in theatre higher education and served in local, state-wide, regional and national leadership positions (including decades for the Kennedy Center American College Theater Festival). I have long fought to add the "A" into the preoccupation of the STEM obsession in both education and our Industrial complex.

While my contact with secondary education is very limited (I judged state high school theatre contests; and have produced an annual Theatre and Dance High School Workshop for the past 35 years), I have seen the direct result of the students produced by that training for decades—I have taught thousands of freshmen college students. I have a life-long interest in pedagogy as well as not-for-profit administration.

I am a practical, practicing theatre artist. I have been a producer as long as I have been a director and I understand the critical importance of funding and appropriate management to get the show done. I balance that with the sensitivity of an artist, trying to produce a vision. Most importantly, I am intrigued by the process and learning environment that can and should be created to produce sustainable and high quality art.

My doctorate is in Fine Arts, with minor cognates in art and music. While clearly specializing in theatre, I appreciate and champion the arts of all kinds, at all levels. I am also very aware of my inherited privilege and have always tried to use that as a way to be as inclusive and diverse as possible. I believe I have amassed an extraordinary skill set, and soon, I will have the time to put it to a different use. I firmly believe in public education and I think that the arts are an essential component of that. I would be honored to be considered for a position that could further that cause.
