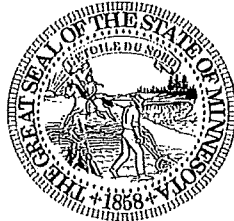

My involvement in government began when I served on a citizen advisory committee looking into housing issues in Roseville. That experience led to my serving on the Roseville City Council, including two terms as mayor, where I gained firsthand knowledge about what affordable housing means to communities.
