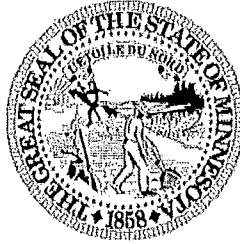

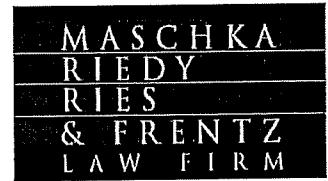

Thus it is with enthusiasm that I recommend Kathy, knowing that she would serve with the effectiveness she has in past positions for which she has been positively recognized by her peers.

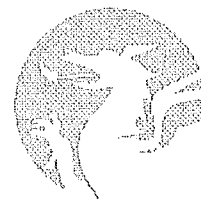

To Whom it May Concern:

Please accept this letter of support as my highest recommendation for Kathy Sheran to be the next State College and University System Board of Trustees appointee for Congressional District 1.

I have lived in Mankato, Minnesota for approximately 23yrs as both a student and a professional. It was as a professional, beginning in 2000, that I began to hear and see the incredible influence of Kathy Sheran in vivid color throughout our community and region. She was and remains a "tireless advocate" (as described in the June 10, 2016 Mankato Free Press upon her retirement from the State Senate) for Minnesota and specifically Southern Minnesota. Kathy's fingerprints on Mankato's vitality and southern Minnesota's vibrancy can be clearly seen from her time as a City Councilor for the City of Mankato (16yrs), as our area's State Senator (10yrs) and now serving as a citizen advocate (her own words) for local and state issues.

While in the State Senate, Kathy served on the Higher Education Committee for the entire duration of her time in the Senate. She was deeply engaged in the legislation to offer more services to first-time higher ed students while also making the case for the State System to increase funding for aid and assistance to students with the greatest need for support to succeed. She understood that the State's colleges and universities best served as well as most frequently served those students in need of additional resources to be successful. She accurately argued that first-time college students – students who were first-generation college students (no previous college graduates in their families); students and families who may have limited financial resources; students and families with no readily available mentors to help them navigate the college "matrix" – should have a college, university and system that

provides additional support that helps them overcome any educational limitations they bring and/or systemic barriers that may exist. Her rationale for this advocacy was simple: Allow whoever wanted to "give it try", to enter our state colleges and universities and do just that. Kathy knew that this is a dynamic that is critical and, in many ways, unique to a statewide, unified higher ed structure like our State System.

Kathy's Senatorial leadership included serving as the Chair of the Senate's Health and Human Services committee, where she worked for increased funding for housing and for increases in the state's aid formula to provide more money to be used for expenses other than tuition. Her push for this change in permissible expenses was a direct correlation to her understanding of the realities confronting marginalized and underrepresented Minnesotans, Minnesotans of color and indigenous people of Minnesota. Kathy proudly used her authority while serving in the Senate to focus on finding ways to actually break down the barriers that hindered the success of Minnesotans.

But she fearlessly led anyway. Plainly stated, whether through her work as an elected official or her time as an engaged community member, Kathy has tirelessly worked to create more ways for more Minnesotans to be more connected, more welcoming and more successful.

With all the above in the forefront of my mind, I respectfully provide my full support for Kathy Sheran to be the next Congressional District 1 appointee to the Board of Trustees for the State College and University System!


