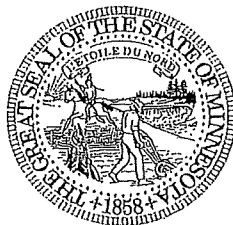


Dear Ladies and Gentlemen,

I have been a commissioner with the Minnesota Racing Commission for the last five years. Prior to that time I had no official business with the racing or gaming industries. During my years as a commissioner, I have been the chair of the Commission's finance committee. The finance committee is concerned with the financial health of Minnesota's two horse race tracks and review of games and operations at the two casinos located at the tracks. I have participated in or chaired a number of disciplinary hearings for suspected violations of rules and statutes related to racing and casino operations. Racing violations range from excessive whipping by a jockey during a race up to a drug related matter for a rider or a race horse.

Horsing is undergoing scrutiny with the recent number of horse fatalities at various race tracks. The safety of horses and jockeys is uppermost on the minds of regulators across the nation. Recent events as well as a long term waning interest in what was once America's most popular spectator sport can further diminish horse breeding and the public interest level. Horse racing in Minnesota is relatively healthy and viable for the future, but this could change as well.

I would work to improve the public's interest in the sport and seek to enhance safety through continued involvement with the Minnesota Racing Commission. I am most enthusiastic about the prospect of being re-appointed to the racing commission.
