## FIRST READING OF HOUSE BILLS

The following bills were read the first time and referred to the committees indicated.

**H.F. No. 184:** A bill for an act relating to appropriations; canceling appropriations for a United Nations trade point and to the office of technology; requiring a report to the legislature.

Referred to the Committee on Governmental Operations and Veterans.

**H.F. No. 214:** A bill for an act relating to health; modifying volunteer ambulance attendant provisions; amending Minnesota Statutes 1998, sections 144E.001, by adding a subdivision; and 144E.35, subdivision 2.

Referred to the Committee on Rules and Administration for comparison with S.F. No. 241, now on the Consent Calendar.

## Senator Vickerman from the Committee on Local and Metropolitan Government, to which was referred

**H.F. No. 133**: A bill for an act relating to local government; repealing authority for certain local residency requirements; repealing Laws 1993, chapter 260; and Laws 1994, chapter 570.

Reports the same back with the recommendation that the bill do pass. Report adopted.

**H.F. No. 6**: A bill for an act relating to recreational vehicles; modifying rulemaking authority; modifying certain restrictions on the use of snowmobile metal traction devices; modifying certain definitions; amending Minnesota Statutes 1998, sections 84.86, subdivision 1; 85.015, subdivision 1c; and 169.1217, subdivision 1; Laws 1998, chapter 401, section 61; repealing Minnesota Statutes 1998, sections 84.871, subdivision 2; and 84.8715; Laws 1998, chapter 401, section 23.

Reports the same back with the recommendation that the bill do pass. Report adopted.

## Senator Sams from the Committee on Agriculture and Rural Development, to which was referred

**S.F. No. 97**: A bill for an act relating to agriculture; exempting hydroponic greenhouses from the corporate farm law; amending Minnesota Statutes 1998, section 500.24, subdivision 2.

Reports the same back with the recommendation that the bill do pass. Report adopted.

## Senator Sams from the Committee on Agriculture and Rural Development, to which was referred

**S.F. No. 254**: A bill for an act relating to taxation; exempting agricultural loans from the mortgage registry tax; amending Minnesota Statutes 1998, section 287.04, by adding a subdivision.

Reports the same back with the recommendation that the bill do pass and be re-referred to the Committee on Taxes. Report adopted.

## Senator Sams from the Committee on Agriculture and Rural Development, to which was referred

**S.F. No. 424**: A bill for an act relating to agriculture; permitting distribution of nonregistered pesticides for certain uses outside the state; amending Minnesota Statutes 1998, section 18B.26, subdivision 1.

Reports the same back with the recommendation that the bill be amended as follows:

Delete everything after the enacting clause and insert:

"Section 1. Minnesota Statutes 1998, section 18B.26, subdivision 1, is amended to read:

Subdivision 1. [REQUIREMENT.] (a) Except as provided in paragraphs (b) to (d), a person may not use or distribute a pesticide in this state unless it is registered with the commissioner. Pesticide registrations expire on December 31 of each year and may be renewed on or before that date for the following calendar year.

- (b) Registration is not required if a pesticide is shipped from one plant or warehouse to another plant or warehouse operated by the same person and used solely at the plant or warehouse as an ingredient in the formulation of a pesticide that is registered under this chapter.
- (c) An unregistered pesticide that was previously registered with the commissioner may be used for a period of two years following the cancellation of the registration of the pesticide, unless the commissioner determines that the continued use of the pesticide would cause unreasonable adverse effects on the environment, or with the written permission of the commissioner. To use the unregistered pesticide at any time after the two-year period, the pesticide end user must demonstrate to the satisfaction of the commissioner, if requested, that the pesticide has been continuously registered under a different brand name or by a different manufacturer and has similar composition, or, the pesticide end user obtains the written permission of the commissioner.
- (d) The commissioner may allow specific pesticide products that are not registered with the commissioner to be distributed in this state for use in another state.
- (e) Each pesticide with a unique United States Environmental Protection Agency pesticide registration number or a unique brand name must be registered with the commissioner.

#### Sec. 2. [EFFECTIVE DATE.]

Section 1 is effective retroactive to January 1, 1999."

And when so amended the bill do pass. Amendments adopted. Report adopted.

## Senator Metzen from the Committee on Governmental Operations and Veterans, to which was referred

**S.F. No. 162**: A bill for an act relating to public employees; making certain changes relating to health coverage for survivors of police officers and firefighters killed in the line of duty; amending Minnesota Statutes 1998, sections 299A.46; and 299A.465, subdivision 2.

Reports the same back with the recommendation that the bill do pass. Report adopted.

## Senator Sams from the Committee on Agriculture and Rural Development, to which was referred

**S.F. No. 428**: A bill for an act relating to agriculture; extending the program for control of pseudorabies in swine; appropriating money.

Reports the same back with the recommendation that the bill be amended as follows:

Page 1, line 6, before "\$1,500,000" insert "(a)"

Page 1, after line 10, insert:

- "(b) Using money appropriated in paragraph (a), when requested by the swine producer, the board shall provide pseudorabies vaccine for swine on premises located within a three-mile radius of a pseudorabies quarantined premise or in other areas recommended by the district veterinarian that are necessary to control the spread of pseudorabies.
- (c) Notwithstanding the bidding requirements in Minnesota Statutes, chapter 16C, or rules of the commissioner of administration, the board shall select the lowest acceptable bid for purchasing swine pseudorabies vaccine under this section and may purchase additional vaccine from the next lowest bidders to provide an adequate amount of vaccine to fulfill the requirements in paragraph (b). The board will make the vaccine available to veterinarians as needed and provide notice to veterinarians and swine producers of the date that the vaccine will be available.
- (d) The board shall provide reimbursement for pseudorabies vaccine to swine producers who purchased the vaccine between January 1, 1999, and the date the vaccine becomes available under paragraph (c) for swine on premises eligible for the vaccine under paragraph (b). Reimbursement shall be computed by using the number of doses purchased for eligible swine during this time period multiplied by the price per dose the board pays for the vaccine under paragraph (c). An eligible swine producer must apply to the board for reimbursement by June 30, 1999.
- (e) The board of animal health shall report to the senate and house agriculture and rural development committees by February 1, 2000, on the reasons for the spread of pseudorabies, including the effect of size and type of swine operation on the spread of the disease, and recommendations for controlling the disease. The report must also analyze the number and location of swine operations eligible for vaccine under paragraph (b) that fail to vaccinate their herds.

## Sec. 2. [APPROPRIATION; CENTER FOR FARM FINANCIAL MANAGEMENT.]

- (a) \$645,000 is appropriated from the general fund to the University of Minnesota for the center for farm financial management to provide financial management assistance to farmers, including assistance with:
  - (1) the preparation of financial records;
  - (2) cash flow planning using FINPACK and other sources; and
  - (3) loan document preparation and planning.

The center for farm financial management shall coordinate the delivery of the financial management assistance through the Minnesota state colleges and universities regional adult farm management offices and provide the training and equipment necessary to persons providing the assistance to farmers.

(b) The center for farm financial management may transfer money appropriated in this section to the board of trustees of the Minnesota state colleges and universities to pay for the costs of coordination through the use of the regional offices and other costs of providing financial management assistance to farmers.

(c) This appropriation is available until June 30, 2000."

Page 1, line 12, delete "Section 1" and insert "This act"

Renumber the sections in sequence

Amend the title as follows:

Page 1, line 3, after the semicolon, insert "providing for the purchase and distribution of pseudorabies vaccine by the board of animal health; providing reimbursement for swine producers who purchased pseudorabies vaccine after January 1, 1999; providing financial management assistance to farmers;"

And when so amended the bill do pass and be re-referred to the Committee on State Government Finance. Amendments adopted. Report adopted.

## Senator Novak from the Committee on Jobs, Energy and Community Development, to which was re-referred

**S.F. No. 57**: A bill for an act relating to agriculture; providing for shared savings loans for demonstration projects of manure processing and odor control technology; requiring purchase of energy from manure waste methane recovery systems; providing rebates; appropriating money; amending Minnesota Statutes 1998, section 17.115, by adding a subdivision; proposing coding for new law in Minnesota Statutes, chapter 216B.

Reports the same back with the recommendation that the bill be amended as follows:

Pages 1 and 2, delete section 2 and insert:

"Sec. 2. Minnesota Statutes 1998, section 216C.41, is amended to read:

216C.41 [RENEWABLE ENERGY PRODUCTION INCENTIVE.]

Subdivision 1. [DEFINITIONS.] (a) The definitions in this subdivision apply to this section.

- (b) "Qualified hydroelectric facility" means a hydroelectric generating facility in this state that:
- (1) is located at the site of a dam, if the dam was in existence as of March 31, 1994; and
- (2) begins generating electricity after July 1, 1994.
- (c) "Qualified wind energy conversion facility" means a wind energy conversion system that:
- (1) produces two megawatts or less of electricity as measured by nameplate rating and begins generating electricity after June 30, 1997, and before July 1, 1999; or
- (2) begins generating electricity after June 30, 1999, produces two megawatts or less of electricity as measured by nameplate rating, and is:
- (i) located within one county and owned by a natural person who owns the land where the facility is sited;
  - (ii) owned by a Minnesota small business as defined in section 645.445;
  - (iii) owned by a nonprofit organization; or
  - (iv) owned by a tribal council if the facility is located within the boundaries of the reservation.
- (d) "Qualified methane recovery facility" means a farm- located farm animal manure waste methane recovery system that is: (1) located in Minnesota; and (2) begins generating electricity after January 1, 1999.
- (e) "Qualified poultry litter electricity facility" means a poultry litter and related biomass to electricity system that:
  - (1) produces 40 megawatts or less electricity;
  - (2) is designed to burn 500,000 tons of poultry litter and related biomass per year; and
  - (3) is located within the state.
- Subd. 2. [INCENTIVE PAYMENT.] Incentive payments shall be made according to this section to the owner or operator of a qualified methane recovery facility, qualified poultry litter electricity facility, qualified hydropower facility, or qualified wind energy conversion facility for electric energy generated and sold by the facility. Payment may only be made upon receipt by the commissioner of finance of an incentive payment application that establishes that the applicant is eligible to receive an incentive payment and that satisfies other requirements the commissioner deems necessary. The application shall be in a form and submitted at a time the commissioner establishes. There is annually appropriated from the general fund sums sufficient to make the payments required under this section.
- Subd. 3. [ELIGIBILITY WINDOW.] Payments may be made under this section only for electricity generated:
- (a) from a qualified hydroelectric facility that is operational and generating electricity before January 1, 2001; or
- (b) from a qualified wind energy conversion facility that is operational and generating electricity before January 1, 2005;
- (c) from a qualified methane recovery facility that is operational and generating electricity before January 1, 2010; or
- (d) from a qualified poultry litter electricity facility that is operational and generating electricity before January 1, 2010.

- Subd. 4. [PAYMENT PERIOD.] A facility may receive payments under this section for a ten-year period. No payment under this section may be made for electricity generated:
  - (a) by a qualified hydroelectric facility after December 31, 2010; or
  - (b) by a qualified wind energy conversion facility after December 31, 2015;
  - (c) by a qualified methane recovery facility after December 31, 2020; or
  - (d) by a qualified poultry litter electricity facility after December 31, 2020.

The payment period begins and runs consecutively from the first year in which electricity generated from the facility is eligible for incentive payment.

- Subd. 5. [AMOUNT OF PAYMENT.] (a) An incentive payment is based on the number of kilowatt hours of electricity generated. The amount of the payment is 1.5 cents per kilowatt hour.
- (b) For electricity generated by qualified wind energy conversion facilities, the incentive payment under this section is limited to no more than 100 megawatts of nameplate capacity. During any period in which qualifying claims for incentive payments exceed 100 megawatts of nameplate capacity, the payments must be made to producers in the order in which the production capacity was brought into production.
- (c) For electricity generated by a qualified methane recovery facility, the incentive payment under this section is limited to no more than 15 megawatts of capacity.
- (d) For electricity generated by a qualified poultry litter electricity facility, the incentive payment under this section is limited to no more than 40 megawatts of capacity."
