### FIRST READING OF HOUSE BILLS

The following bills were read the first time and referred to the committees indicated.

**H.F. No. 5:** A bill for an act relating to the legislature; proposing an amendment to the Minnesota Constitution by adding a section to article IV; requiring a three-fifths vote to enact a law increasing taxes or certain fees or surcharges.

Referred to the Committee on Taxes.

**H.F. No. 414:** A bill for an act relating to agriculture; extending the program for control of pseudorabies in swine; appropriating money.

Referred to the Committee on Rules and Administration for comparison with S.F. No. 428, now on the Calendar.

**H.F. No. 352:** A bill for an act relating to health; directing the commissioner of health to exempt certain wading pools from the requirements for public swimming pools.

Referred to the Committee on Health and Family Security.

**H.F. No. 454:** A bill for an act relating to health; modifying requirements for nursing home administrators; amending Minnesota Statutes 1998, section 144A.04, subdivisions 5 and 7a.

Referred to the Committee on Rules and Administration for comparison with S.F. No. 564.

**H.F. No. 544:** A resolution urging the Office of the United States Trade Representative to forcefully and promptly address and resolve violations of international trade agreements and discriminatory practices by the Province of Ontario and Canadian officials that are injuring Minnesota border lakes tourism businesses.

Referred to the Committee on Rules and Administration for comparison with S.F. No. 638, now on General Orders.

**S.F. No. 567:** A bill for an act relating to community development; clarifying and restating the powers of the rural policy and development center; providing for temporary employment of persons severely affected by the recent decline in agricultural commodity prices; appropriating money; amending Minnesota Statutes 1998, section 116J.421, subdivision 3, and by adding subdivisions.

**S.F. No. 914:** A bill for an act relating to electric utilities; revising the house chairs appointed to the legislative electric energy task force; amending Minnesota Statutes 1998, section 216C.051, subdivision 2.

Reports the same back with the recommendation that the bill do pass and be placed on the Consent Calendar. Report adopted.

#### **Senator Marty from the Committee on Election Laws, to which was referred**

**S.F. No. 519:** A bill for an act relating to elections; requiring certain special primaries and elections to be conducted by mail; changing certain election schedules; amending Minnesota Statutes 1998, sections 204D.19, subdivisions 1 and 2; 204D.20, subdivision 1; 204D.21, subdivisions 2 and 3; 204D.22, subdivision 3; and 204D.23, subdivision 2; repealing Minnesota Statutes 1998, section 204D.19, subdivision 3.

Reports the same back with the recommendation that the bill do pass. Report adopted.

**Senator Marty from the Committee on Election Laws, to which was referred**

**S.F. No. 257:** A bill for an act relating to statutory cities; permitting special elections in cases of certain vacancies; amending Minnesota Statutes 1998, sections 205.10, subdivision 2; and 412.02, subdivision 2a.

Reports the same back with the recommendation that the bill be amended as follows:

Page 1, line 10, strike everything after "cities"

Page 1, line 11, strike "general elections"

**Senator Spear from the Committee on Crime Prevention, to which was referred**

**S.F. No. 198:** A bill for an act relating to criminal procedure; specifying that the prosecution may reply in rebuttal to the closing argument of the defense; amending Minnesota Statutes 1998, section 631.07.

Reports the same back with the recommendation that the bill be amended as follows:

Page 1, line 18, delete "may" and insert "shall" and after "then" insert "have the right to"

Amend the title as follows:

Page 1, line 3, delete "may" and insert "has the right to"

And when so amended the bill do pass. Amendments adopted. Report adopted.

**Senator Spear from the Committee on Crime Prevention, to which was referred**

**S.F. No. 443:** A bill for an act relating to crime prevention; expanding reporting requirements for health professionals concerning injuries resulting from alcohol- or controlled substance-related accidents; expanding civil and criminal immunity for reports by health professionals; amending Minnesota Statutes 1998, sections 626.52; and 626.55, subdivision 1; repealing Minnesota Statutes 1998, section 626.55, subdivision 2.

Reports the same back with the recommendation that the bill be amended as follows:

Page 2, line 11, delete "shall immediately" and insert "may"

Page 2, line 12, delete "local police department or county sheriff" and insert "proper police authorities"

Page 2, line 15, delete "involved" and insert "was an occupant of a motor vehicle and"

Page 2, line 16, delete "in the accident" and after the period, insert "Notwithstanding section 13.04, subdivision 2, a health care professional is not required to inform an individual who is asked to supply government data that the data may be used to make a report under this paragraph."

Page 2, line 27, after "reporting" insert "pursuant to this section or section 626.53"

Page 2, line 30, delete "pursuant to this section" and after the period, insert "A health professional may not be subjected to administrative license sanctions for reporting or failing to report pursuant to subdivision 2, paragraph (c)."

Page 2, line 32, after "section" insert "or section 626.53"

And when so amended the bill do pass and be re-referred to the Committee on Judiciary. Amendments adopted. Report adopted.

### **Senator Flynn from the Committee on Transportation, to which was referred**

**S.F. No. 660:** A bill for an act relating to public safety; governing cost of identification card for person with serious and persistent mental illness; amending Minnesota Statutes 1998, section 171.07, subdivision 3.

Reports the same back with the recommendation that the bill be amended as follows:

Delete everything after the enacting clause and insert:

"Section 1. Minnesota Statutes 1998, section 13.69, subdivision 1, is amended to read:

Subdivision 1. [CLASSIFICATIONS.] (a) The following government data of the department of public safety are private data:

(1) medical data on driving instructors, licensed drivers, and applicants for parking certificates and special license plates issued to physically handicapped persons;

(2) other data on holders of a disability certificate under section 169.345, except that data that are not medical data may be released to law enforcement agencies;

(3) social security numbers in driver's license and motor vehicle registration records, except that social security numbers must be provided to the department of revenue for purposes of tax administration and the department of labor and industry for purposes of workers' compensation administration and enforcement; and

(4) data on persons listed as designated caregivers under section 171.07, subdivision 11, except that the data must be released to:

(i) law enforcement agencies for the purpose of verifying that an individual is a designated caregiver; or

(ii) law enforcement agencies who state that the license holder is unable to communicate at that time and that the information is necessary for notifying the designated caregiver of the need to care for a child of the license holder; and

(5) data relating to individuals who qualify for a reduced fee for a Minnesota identification card under section 171.07, subdivision 3, paragraph (c).

(b) The following government data of the department of public safety are confidential data: data concerning an individual's driving ability when that data is received from a member of the individual's family.

Sec. 2. Minnesota Statutes 1998, section 171.07, subdivision 3, is amended to read:

Subd. 3. [IDENTIFICATION CARD; FEE.] (a) Upon payment of the required fee, the department shall issue to every applicant therefor a Minnesota identification card. The department may not issue a Minnesota identification card to a person who has a driver's license, other than an instruction permit or a limited license. The card must bear a distinguishing number assigned to the applicant, a colored photograph or an electronically produced image, the full name, date of birth, residence address, a description of the applicant in the manner as the commissioner deems

necessary, and a space upon which the applicant shall write the usual signature and the date of birth of the applicant with pen and ink. Each identification card issued to an applicant under the age of 21 must be of a distinguishing color and plainly marked "Under-21."

(b) Each Minnesota identification card must be plainly marked "Minnesota identification card - not a driver's license."

(c) The fee for a Minnesota identification card is 50 cents when issued to: a person who is mentally retarded, as defined in section 252A.02, subdivision 2, or to a physically disabled person, as defined in section 169.345, subdivision 2, is 50 cents and who presents a certification by a psychologist stating that the applicant is mentally retarded; a physically disabled person, as defined in section 169.345, subdivision 2, who presents a certification by a physician or chiropractor stating that the applicant is physically disabled; or a person with serious and persistent mental illness, as described in section 245.462, subdivision 20, paragraph (c), who presents a certification by a mental health professional stating that the applicant has such an illness.

### Sec. 3. [EFFECTIVE DATE.]

Sections 1 and 2 are effective July 1, 1999, for Minnesota identification cards issued on and after that date."

Delete the title and insert:

"A bill for an act relating to public safety; characterizing certain data as private; reducing cost of identification card for person with serious and persistent mental illness; amending Minnesota Statutes 1998, sections 13.69, subdivision 1; and 171.07, subdivision 3."

And when so amended the bill do pass and be re-referred to the Committee on Judiciary. Amendments adopted. Report adopted.

### **Senator Flynn from the Committee on Transportation, to which was referred**

**S.F. No. 460:** A bill for an act relating to motor vehicles; allowing disability license plates to be issued for vehicles modified for use by disabled persons; amending Minnesota Statutes 1998, section 168.021, subdivision 1.

Reports the same back with the recommendation that the bill be amended as follows:

Delete everything after the enacting clause and insert:

"Section 1. Minnesota Statutes 1998, section 168.021, subdivision 1, is amended to read:

Subdivision 1. [SPECIAL PLATES; APPLICATION.] (a) When a motor vehicle registered under section 168.017, a motorcycle, a truck having a manufacturer's nominal rated capacity of one ton and resembling a pickup truck, or a self-propelled recreational vehicle is owned or primarily operated by a permanently physically disabled person or a custodial parent or guardian of a permanently physically disabled minor, the owner may apply for and secure from the registrar of motor vehicles (1) immediately, a temporary permit valid for 30 days, if the applicant is eligible for the special plates issued under this paragraph, and (2) two license plates with attached emblems, one plate to be attached to the front, and one to the rear of the vehicle. When the owner first applies for the plates, the owner must submit a physician's statement on a form developed by the commissioner under section 169.345, or proof of physical disability provided for in that section, except that no physician's statement or proof of disability is required when an owner applies for plates for one or more commercial motor vehicles that are specially modified for and used exclusively by permanently physically disabled persons.

(b) The owner of a motor vehicle may apply for and secure (i) immediately, a temporary permit valid for 30 days, if the person is eligible to receive the special plates issued under this paragraph, and (ii) a set of special plates for a motor vehicle if:

(1) the owner employs a permanently physically disabled person who would qualify for special plates under this section; and

(2) the owner furnishes the motor vehicle to the physically disabled person for the exclusive use of that person in the course of employment."

And when so amended the bill do pass and be placed on the Consent Calendar. Amendments adopted. Report adopted.

**Senator Solon from the Committee on Commerce, to which was referred**

**S.F. No. 583:** A bill for an act relating to commerce; requiring certain fire protection notifications in contracts for the sale of certain newly constructed residential dwellings; proposing coding for new law in Minnesota Statutes, chapter 325F.

Reports the same back with the recommendation that the bill be amended as follows:

Page 1, lines 13 and 14, delete "and includes a detached garage"

And when so amended the bill do pass. Amendments adopted. Report adopted.

**Senator Hottinger from the Committee on Health and Family Security, to which was referred**

**S.F. No. 488:** A bill for an act relating to mental health; modifying membership, duties, and reporting requirements for the state advisory council on mental health; amending Minnesota Statutes 1998, section 245.697.

**MOTIONS AND RESOLUTIONS - CONTINUED**

Senator Spear moved that Senate Resolution No. 39 be taken from the table. The motion prevailed.

**Senate Resolution No. 39:** A Senate resolution recognizing a day of remembrance for Japanese internees.

WHEREAS, on February 19, 1942, President Franklin D. Roosevelt issued Executive Order 9066, which authorized the forced assembly, evacuation, and internment of approximately 120,000 Japanese Americans residing in Alaska, Washington, Oregon, California, and Arizona; and

WHEREAS, the order for assembly and detention leading to the evacuation and subsequent internment of Japanese Americans caused them to lose millions of dollars in property and assets, to suffer immeasurable physical and psychological damage, and to be deprived of their constitutional liberties without due process of law because they were assumed to be disloyal; and

WHEREAS, an overwhelming number demonstrated incredible patriotism to the United States of America by volunteering to serve in the United States Military, including its Military Intelligence Service Language School based at Camp Savage in Savage, Minnesota, and later moved to Fort Snelling; and

WHEREAS, about 5,000 Japanese American officers and enlisted men graduated from Camp Savage, and after learning the Japanese language they became the eyes and ears of the Allied Forces which fought the Japanese forces in the Pacific battles acclaimed by General Willoughby, Chief Intelligence for General MacArthur, for shortening the Pacific War by two years; and

WHEREAS, Japanese Americans from the Military Intelligence Service Language School recruited volunteers from the internment camps for the U.S. Army's 442nd Regimental Combat Team which became the most decorated American unit of its size in World War II with seven Presidential Unit Citations, a Congressional Medal of Honor, 52 Distinguished Service Crosses, 588 Silver Stars, 4,000 Bronze Stars, 9,486 Purple Hearts, and a total of 18 decorations from France and Italy; and

WHEREAS, patriotic Japanese Americans relocated to Minnesota, establishing residency in this State, bringing with them their parents, brothers and sisters, and raising their children and grandchildren; and

WHEREAS, Minnesota's population of Japanese Americans, all of whom call this great State their home, have contributed for generations to Minnesota's economic prosperity, to our social and educational fabric, to our faith community, and have set high standards by their initiative, industry, and citizenship; NOW, THEREFORE,

BE IT RESOLVED by the Senate of the State of Minnesota that it, along with the people of Minnesota, pause in its endeavors on February 19, 2000, to recognize the Japanese American internees from the State of Minnesota and honor their patience, heroism, sacrifice, and patriotic loyalty, and to remember the lessons and blessings of liberty and justice for all; and

BE IT FURTHER RESOLVED that the Secretary of the Senate is directed to prepare an enrolled copy of this resolution, to be authenticated by his signature and that of the Chair of the Senate Rules and Administration Committee, and transmit it to the Japanese American Veterans of Minnesota and to the Minnesota Chapter of the Japanese American Citizens League.
