**S.F. No. 17:** A bill for an act relating to taxation; providing for payment of a sales tax rebate; appropriating money.

#### **Senator Knutson introduced--**

**S.F. No. 18:** A bill for an act relating to employment; requiring certain apartment manager background checks to be performed on individuals who have resided in Minnesota less than ten years; amending Minnesota Statutes 2000, section 299C.68, subdivisions 2, 3.

Senator Moe, R.D. moved that S.F. No. 18 be laid on the table. The motion prevailed.

#### **Senator Knutson introduced--**

**S.F. No. 19:** A bill for an act relating to employment; requiring disclosure of data between school districts relating to acts of violence or inappropriate sexual contact with students; providing protection for disclosure of job reference information; requiring disclosure of certain employee rights; requiring certain apartment manager background checks to be performed on individuals who have resided in Minnesota less than ten years; amending Minnesota Statutes 2000, sections 13.43, by adding a subdivision; 299C.68, subdivisions 2, 3; proposing coding for new law in Minnesota Statutes, chapter 181.

Senator Moe, R.D. moved that S.F. No. 19 be laid on the table. The motion prevailed.
