# Senator Marty from the Committee on Environment and Natural Resources, to which was referred

**S.F. No. 203:** A bill for an act relating to water; restricting the use of phosphorus in dishwashers and detergents; amending Minnesota Statutes 2002, section 116.23.

Reports the same back with the recommendation that the bill be amended as follows:

Delete everything after the enacting clause and insert:

"Section 1. Minnesota Statutes 2002, section 116.23, is amended to read:

# 116.23 [PROHIBITION AND RESTRICTIONS.]

<u>Subdivision 1.</u> [NUTRIENT CONCENTRATIONS.] No person shall manufacture for use or sale in Minnesota or import into Minnesota for resale any cleaning agent or chemical water conditioner which contains a prescribed nutrient in a concentration that is greater than the prescribed maximum permissible concentration of that nutrient in that cleaning agent or chemical water conditioner.

Subd. 2. [RESIDENTIAL DISHWASHER DETERGENT.] No person shall manufacture for use or sale in Minnesota or import into the state for resale any household dishwasher detergent that contains more than 0.5 percent phosphorus by weight.

Sec. 2. [EFFECTIVE DATE.]

Section 1 is effective August 1, 2004."

Amend the title as follows:

Page 1, line 3, delete "dishwashers and detergents" and insert "household dishwasher detergent"

And when so amended the bill do pass.
