(3) Mayo Clinic Hospital, St. Mary's Campus, \$413,000;

(4) the University of Minnesota Medical Center, \$508,000; and

(5) \$148,000 to the Emergency Medical Services Regulatory Board for service providers who can demonstrate extraordinary costs directly attributable to maintaining a state of readiness with respect to the public health threat posed by Ebola. The Emergency Medical Services Regulatory Board shall proportionally allocate this grant to these service providers.

The commissioner shall make no payments under this paragraph for expenses that are reimbursable with federal funds.

(c) The appropriations in this section are onetime."

Page 3, line 9, delete "\$1,500,000" and insert "\$1,350,000"

Page 3, line 10, after the period, insert "This appropriation is onetime."

Page 3, line 12, delete "7" and insert "4"

Renumber the sections in sequence

Amend the title as follows:

Page 1, line 3, delete "disaster assistance,"

Page 1, line 5, delete everything after first semicolon

Page 1, line 6, delete everything before "appropriating"

Senator Sheran from the Committee on Health, Human Services and Housing, to which was referred

S.F. No. 379: A bill for an act relating to health; eliminating the requirement of a variance for a staff requirement for ambulance services; allowing a medical director of an ambulance service to authorize certain staffing requirements in limited areas; amending Minnesota Statutes 2014, section 144E.101, subdivision 6.

Subd. 12. **Mutual aid agreement.** (a) A licensee shall have a written agreement with at least one neighboring licensed ambulance service for the preplanned and organized response of emergency medical services, and other emergency personnel and equipment, to a request for assistance in an emergency when local ambulance transport resources have been expended. The response is predicated upon formal agreements among participating ambulance services. A copy of each mutual aid agreement shall be maintained in the files of the licensee.

(b) A licensee may have a written agreement with a neighboring licensed ambulance service, including a licensed ambulance service from a neighboring state if that service is currently and remains in compliance with its home state licensing requirements, to provide part-time support to the primary service area of the licensee upon the licensee's request. The agreement may allow the licensee to suspend ambulance services in its primary service area during the times the neighboring licensed ambulance service has agreed to provide all emergency services to the licensee's primary service area. The agreement may not permit the neighboring licensed ambulance service to serve the licensee's primary service area for more than 12 hours per day. This paragraph applies only to an ambulance service whose primary service area is mainly located outside the metropolitan counties listed in section 473.121, subdivision 4, and outside the cities of Duluth, Mankato, Moorhead, Rochester, and St. Cloud, or an ambulance based in a community with a population of less than 2,500 persons.

Sec. 3. EFFECTIVE DATE.

Sections 1 and 2 are effective the day following final enactment."

Delete everything after the enacting clause and insert:

"Section 1. [116L.31] DUAL TRAINING COMPETENCY GRANTS.

Subdivision 1. **Program created.** The commissioner of employment and economic development shall make grants for the training of employees to achieve the competency standard for an occupation identified by the commissioner of labor and industry under section 175.45 and Laws 2014, chapter 312, article 3, section 21.

Subd. 2. Eligible grantees. An employer or an organization representing the employer is eligible to apply for a grant to train employees if the employer has employees who are in or are to be trained to be in an occupation for which a competency standard has been identified and the employee has not attained the competency standard prior to the commencement of the planned training. Training need not address all aspects of a competency standard but may address only the competencies of a standard that an employee is lacking.

Subd. 3. Training institution or program. Prior to applying for a grant, the employer must have an agreement with a training institution or program to provide the employee competency standard training. The training may be provided by any institution or program having trainers qualified to instruct on the competency standard.

Subd. 4. Application. Applications must be made to the commissioner on a form provided by the commissioner. The commissioner must make best efforts to make the application form as short and simple to complete as is reasonably possible. The commissioner shall establish a schedule for applications and grants. The application must include, without limitation:

(1) the projected number of employee trainees;

(2) the competency standard for which training will be provided;

(3) any credential the employee will receive upon completion of training;

(4) the name and address of the training institution or program and a signed statement by the institution or program that it is able and agrees to provide the training;

(5) the period of the training; and

(6) the cost of the training charged by the training institution or program and certified by the institution or program.

An application may be made for training of employees of multiple employers either by the employers or by an organization on their behalf.

Subd. 5. Grant criteria. The commissioner shall, to the extent there are sufficient applications, make at least an equal dollar amount of grants for training for employees whose work site is projected to be outside the metropolitan area as defined in section 473.121, subdivision 2, as for employees whose work site is projected to be within the metropolitan area. The commissioner shall give preference to grants that provide training to employees that are women or members of racial and ethnic minorities. Within the metropolitan area to the extent there are sufficient applications, the commissioner shall award at least 20 percent of available grant funds for training by employees who are members of racial and ethnic minorities. In determining the award of grants, the commissioner must consider, among other factors:

(1) the aggregate state and regional need for employees with the competency to be trained;

(2) the per employee cost of training;

(3) the additional employment opportunities for employees because of the training;

(4) projected increases in compensation for employees receiving the training; and

(5) the amount of employer training cost match, if required, on both a per employee and aggregate basis.

Subd. 6. Employer match. A large employer must pay for at least 25 percent of the training institution's or program's charge for the training to the training institution or program. For the purpose of this subdivision, a "large employer" means a business with more than \$25,000,000 in annual revenue in the previous calendar year.

Subd. 7. Payment of grant. The commissioner shall make grant payments to the training institution or program in a manner determined by the commissioner after receiving notice from the institution or program that the employer has paid the employer match.

Subd. 8. Grant amounts. The maximum amount of a grant may not exceed \$..... The maximum grant per employee trained under a grant may not exceed \$.....

A grant for a particular employee must be reduced by the amounts of any federal Pell grant or state grant the employee is eligible to receive for the training and an employee must apply for those grants as a condition of payment for training that employee under this section.

Subd. 9. **Reporting.** Commencing in 2017, the commissioner shall annually by February 1 report on the activity of the grant program for the preceding fiscal year to the chairs of the legislative committees with jurisdiction over workforce policy and finance.

The report must, at a minimum, include:

(1) research and analysis on the costs, return on investment, and benefits of the grants for employees, employers, training institutions, and the state;

(2) the number of employees who commenced training and the number who completed training; and

(3) recommendations, if any, for amendments to the grant program.

EFFECTIVE DATE. This section is effective July 1, 2015.

Sec. 2. [175.45] COMPETENCY STANDARDS FOR DUAL TRAINING.

Subdivision 1. **Duties; goal.** The commissioner of labor and industry shall identify competency standards for dual training. The goal of dual training is to provide current employees of an employer with training to acquire competencies that the employer requires. The standards shall be identified for employment in occupations in advanced manufacturing, health care services, information technology, and agriculture. The identification of standards is not subject to chapter 14.

Subd. 2. **Definition; competency standard.** For purposes of this section, "competency standards" means the specific knowledge and skills necessary for a particular occupation.

Subd. 3. Competency standard identification process. In identifying competency standards, the commissioner shall consult with the commissioner of employment and economic development and convene recognized industry experts, representative employers, higher education institutions, and representatives of labor to assist in identifying credible competency standards. Competency standards must be based, to the extent available and practical, on recognized international and national standards.

Subd. 4. Duties. The commissioner shall:

(1) establish competency standards for entry level and higher skill levels;

(2) verify the competency standards and skill levels and their transferability by subject matter expert representatives of each respective industry;

(3) create and execute a plan for dual training outreach, development, and awareness, including awareness of disenfranchised communities in the metropolitan area;

(4) develop models for Minnesota educational institutions to engage in providing education and training to meet the competency standards established;

(5) encourage participation by employers and labor in the standard identification process for occupations in their industry; and

(6) align dual training competency standards with other workforce initiatives.

Subd. 5. Notification. The commissioner must communicate identified competency standards to the commissioner of employment and economic development for the purpose of the dual training competency grant program under section 116L.31. The commissioner of labor and industry shall maintain the competency standards on the department's Web site.

Sec. 3. DUAL TRAINING COMPETENCY GRANTS; APPROPRIATION.

<u>\$.....</u> in fiscal year 2016 and \$..... in fiscal year 2017 are appropriated from the general fund to the commissioner of employment and economic development for the purpose of making training grants under Minnesota Statutes, section 116L.31.

Sec. 4. APPROPRIATION.

\$..... is appropriated in fiscal year 2016 from the general fund to the commissioner of labor and industry for identification of competency standards for dual training under Minnesota Statutes, section 175.45."
