WHEREAS, the Governor issued Executive Orders 20-2, 20-19, 20-41, and 20-57, regarding the operation of public schools; and

WHEREAS, under the Minnesota Constitution, Article XIII, section 1, it is the responsibility of the legislature to secure a thorough and efficient system of public schools throughout the state; and

WHEREAS, our public schools provide an essential service to their surrounding communities; and

WHEREAS, local officials are better suited to respond to the distinct needs of their communities; and

WHEREAS, responding to an emergency is not the same in every public school or school district statewide; and

WHEREAS, public school leaders should be able to determine the need for school closures in their community; and

NOW, THEREFORE, BE IT RESOLVED by the Senate of the State of Minnesota that the Governor should not exercise the emergency powers in Minnesota Statutes, section 12.21, subdivision 3, clause (11), to alter school schedules, curtail school activities, or order schools closed and prevent the reopening of schools for the 2020-2021 school year and the typical presence of students in school buildings.

BE IT FURTHER RESOLVED that the Secretary of the Senate is directed to prepare an enrolled copy of this resolution, to be authenticated by his signature and that of the Chair of the Senate Rules and Administration Committee, and transmit it to the Governor of the State of Minnesota.
